

बेगम हजरत महल राष्ट्रीय छात्रवृत्ति योजना

राष्ट्रीय अल्पसंख्यक कार्य मंत्रालय, भारत सरकार, नई दिल्ली के अधीन कार्यरत मौलाना आजाद एजुकेशन फाउण्डेशन (MAEF) के माध्यम से अल्पसंख्यक समुदाय के प्रतिभाशाली लड़कियों के लिए बेगम हजरत महल राष्ट्रीय छात्रवृत्ति योजना (BHMNS) आरम्भ की गई है। इस योजना के तहत एकमुश्त छात्रवृत्ति 9वीं एवं 10वीं की बच्चियों के लिए @ 5000/-रु० (पाँच हजार) रुपये एवं 11वीं एवं 12वीं के लिए @ 6000/-रु० (छः हजार) रुपये प्रदान की जाती है। योजना के तहत छात्रवृत्ति की राशि उन्हीं छात्राओं को प्रदान की जाती है जिन्होंने पिछले वर्ष की परीक्षा में 50% अंक प्राप्त किया है। वित्तीय वर्ष 2021-22 में इस छात्रवृत्ति का क्रियान्वयन NSP (National Scholarship Portal) के माध्यम से किया जा रहा है। विस्तृत जानकारी झारखण्ड राज्य अल्पसंख्यक वित्त एवं विकास निगम के साईट- www.jsmfdc.com पर देखा जा सकता है।

Respected Sir,

Maulana Azad Education Foundation (MAEF) is an autonomous body under the Ministry of Minority Affairs, Govt. of India established to promote education amongst the educationally backward minorities. The MAEF is fully funded by the Govt. of India and the Hon'ble Minister of Minority Affairs is Ex-Officio President of the MAEF.

MAEF is implementing Begum Hazrat Mahal National Scholarship (BHMNS) scheme for meritorious girls belonging to notified minorities (i.e. Muslim, Christian, Sikh, Buddhist, Parsi and Jain) who cannot continue their education without financial support. One time Scholarship is given under this scheme to girls studying in classes 9th, 10th, 11th & 12th (i.e., @Rs.5,000/- to each beneficiary for classes 9th & 10th and @Rs.6,000/- per beneficiary for classes 11th & 12th subject to fulfillment of eligibility criteria. The applicant must belong to minorities, confirm admission in respective class, 50% marks in previous exam passed (However, this condition has been relaxed for this year, 2021-22) and, whose parents' annual income upto Rs.2 lakh are eligible to apply.

The BHMNS Scheme will now be implemented through the National Scholarship Portal (NSP), on the same line as the Pre-Matric & Post Matric Scholarship scheme of the MoMA, from this year i.e. 2021-22. Hence, it is requested that the State Nodal Officers (SNOs) / District Nodal Officers (DNOs) who are assigned verification of applications under the Pre & Post Matric Schemes of MoMA (list enclosed for ready reference) may also be nominated for the said purpose for BHMNS Scheme under intimation to us. For this purpose login ID & password created for SNOs / DNOs in your State / UT are attached herewith. These login ID & password may be provided to SNOs / DNOs in your State / UT for verification of applications received under BHMNS Scheme. Since login ID & password is sensitive issue these may be kept highly confidential. Further as the verification has already started, I shall be grateful if necessary action in this regard is taken at the earliest.
